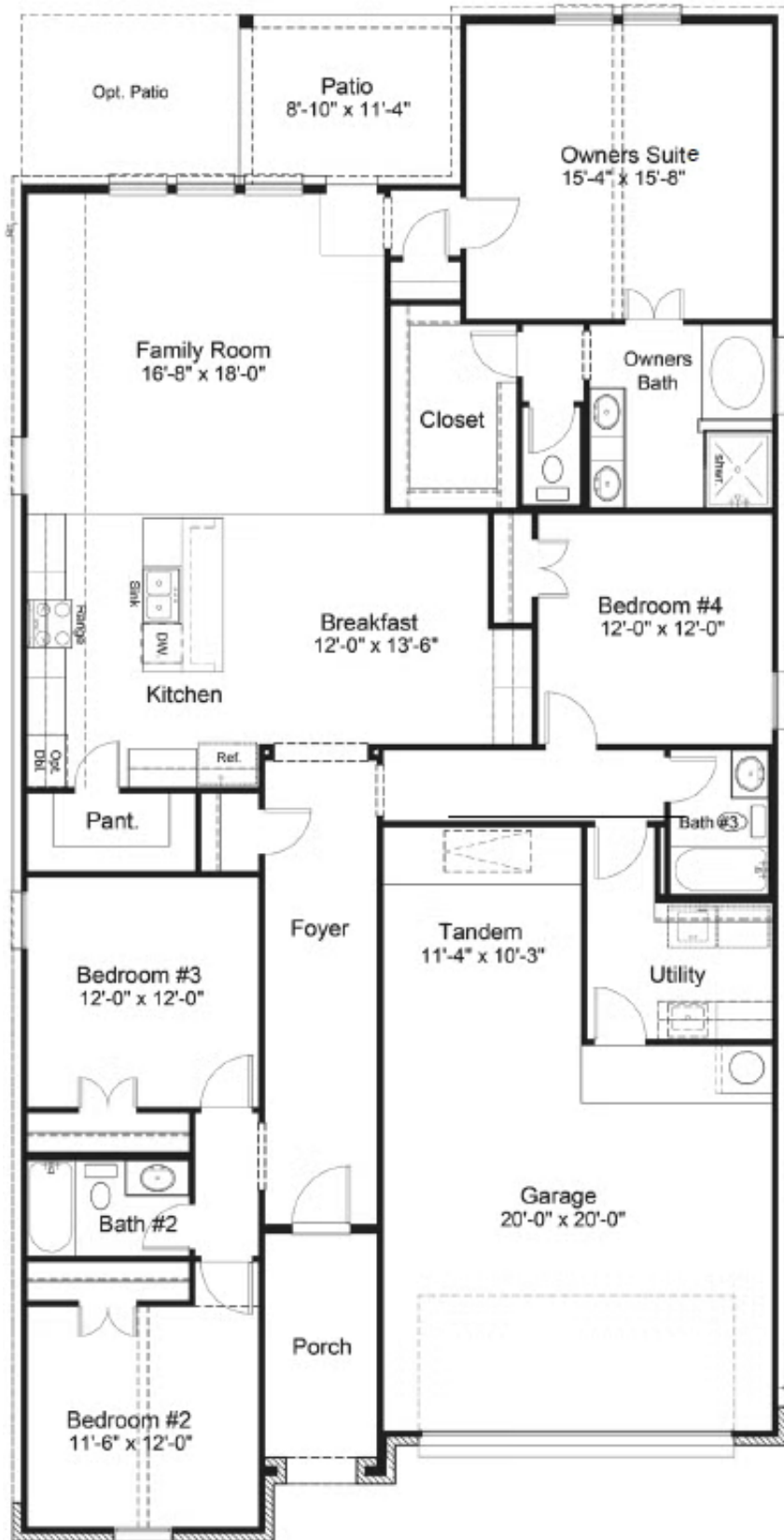

SAVOY FLOORPLAN

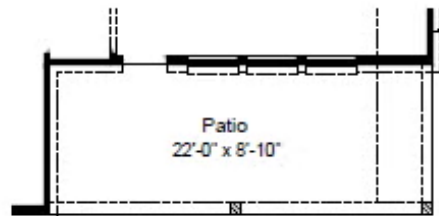
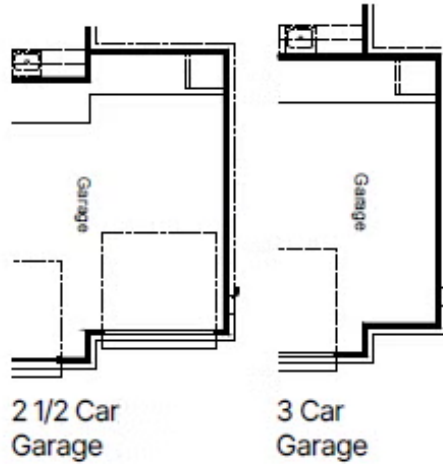
