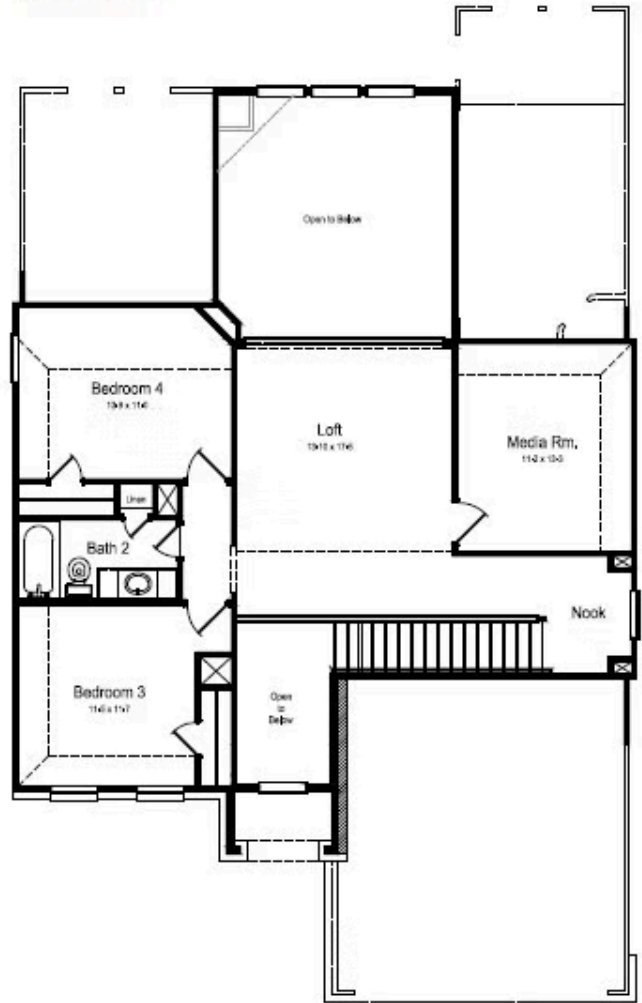

1st Floor



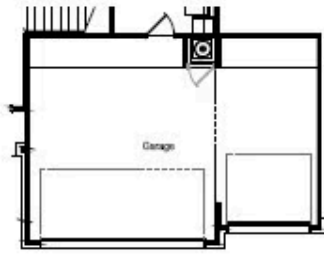
